**Bank Draft Form Must Be Completed for Bank Draft Payments*

The member agrees to pay a \$100.00 deposit fee and a \$5.00 non-refundable membership fee. This deposit will serve as a guarantee of payment in the event of discontinuation of service. The deposit, less any indebtedness will be refunded to the member. The member agrees that no other present or future sources of water will be connected to any waterlines served by Cason Water and will disconnect from the present water supply prior to connecting to and switching to Cason Water's system and shall eliminate their present or future cross-connection in the water system. Water charges to the member shall commence on the date when service is made available, regardless of whether the member connects to the system. The Member agrees that the water bill will be paid in full for water service by the 10th of each month in which it is due. If unpaid by the 10th, a 10% late fee will be added to the bill. If the bill is not paid within 30 days of receipt, water service will be discontinued. For non-payment a \$75.00 lock fee will be applied before water service is reinstated. In the event the meter has been locked, and meter is tampered with in any way there will be an additional fee of \$250.00 for unauthorized use of water. The member shall not receive, nor shall Cason Water be obligated to provide any further water service to the customer, until all indebtedness is paid in full. The applicant agrees that they have followed the guidelines set forth by the Mississippi State Department of Health regarding onsite wastewater disposal.
